General Manager Fraser initiated discussion on item 2g.

On behalf of Vavrinek, Trine, Day & Co., LLP, external auditor Phillip White presented the clean, unmodified opinion for the audit of the 2015 Financial Report. Items pointed out to the board included: Note 12-Defined Benefit Pension Plan, and explained the new accounting pronouncement GASB 68 relating to pensions, which includes a new liability reporting for pensions. He also shared there were no difficulties in collecting information from management; realistic estimates were used in valuing dedicated capital assets; prior period adjustments; and internal controls.

After discussion, President Cottrell motioned to accept and receive item 2g, the 2015 audited Annual Financial Report. The motion was seconded by Director Hoffman and passed 5-0 by roll call: Director Covington - Aye; Director Hoffman - Aye; President Cottrell – Aye; Director Slawson – Aye; Director Douglass – Aye.

3. California Special Districts Association (CSDA) 2016 Board Elections: Vote To Elect A Representative to the California Special District Association Board of Directors in our Network for Seat B.\*\*(pages 118-126)

After discussion, President Cottrell motioned to issue a vote for Ronald Coats. The motion was seconded by Director Douglass and passed 5-0 by roll call: Director Covington - Aye; Director Hoffman - Aye; President Cottrell – Aye; Director Slawson – Aye; Director Douglass – Aye.

4. Consideration of Request for "Will Serve Letter" for Proposed Low Income Veterans Housing Project – Illinois Avenue, Beaumont, CA (Riverside County Assessor's Parcel No's 418-020-027, -032, -033, -034).\*\* (pages 127-152)

### Public Comment on Item:

*Mr.* Michael De La Torre, from Linc Housing, explained they have obtained one hundred percent funding for the Veteran Housing Project and is requesting a "Will Serve Letter" to move forward with the development.

Director of Engineering Dan Jaggers gave an overview of the Board's prior consideration for a "Will Serve Letter" at the June 10, 2015 Board of Directors Meeting and explained that the Board had directed staff and legal counsel to prepare a letter of support, and non-binding intent to serve, so that the applicant could move forward with the project funding. He also explained that District staff has done an analysis of water available and explained that the District meets the State's requirements now that the State's water conservation emergency regulations were modified.

After discussion, Director Covington motioned to approve the "Will Serve Letter". The motion was seconded by Director Hoffman and passed 5-0 by roll call: Director Covington - Aye; Director Hoffman - Aye; President Cottrell – Aye; Director Slawson – Aye; Director Douglass – Aye.

5. Update Regarding the Acquisition of Imported Water Supply from the San Gorgonio Pass Water Agency for New Water System Connections.\*\* (pages 153-154)

General Manager Fraser gave an overview of the update request he made to the San Gorgonio Pass Water Agency (SGPWA) in regards to water availability from SGPWA and the District's new water system connections. He shared the ongoing concerns the District faces when it comes to the assurance of available water when issuing a "Will Serve Letter". He further stated that another major concern is the collection of a Capacity Fee. SGPWA is negotiating with cities and water purveyors, and the lack of assurance that the funds collected are adequate to actually fund the purchase of new entitlement is a major concern.

### Public Comment on Item:

*Mr. Mike Turner, from Argent Management, shared that he was pleased with the dialogue that was happening between the BCVWD and the SGPWA. He shared his knowledge of the Cooperative Agreement between the SGPWA and Yucaipa Valley Water District and encouraged BCVWD to work together with the SGPWA in also creating a Cooperative Agreement.* 

*Mr.* Jeff Davis, General Manager of the SGPWA, gave an update on three significant events. The first was the potential water purchase agreement with the San Bernardino Valley Municipal Water District (SBVMWD). He explained that SBVMWD has agreed to place the SGPWA first in line to receive the sale of water, and that in the past SBVMWD has had surplus of water available and sold it to MWD. He explained that the water was not available this year, but perhaps next year, depending if it's a wet year. Secondly, his agency's Board has authorized participation in the Sites Reservoir Project phase 1 for 10,000 acre feet of water. This is a reservoir that might, or might not, get built in the next ten to twenty years. He explained his agency is trying to make sure they have multiple options for water acquirement. Thirdly, SGPWA has entered into an agreement with a consulting firm to conduct a study of water supply available for purchase. He stated his agency should have a draft of the study by late September.

## 6. Presentation by SGPWA Regarding the Sites Reservoir Project.\*\*(pages 155-176)

General Manager Fraser expressed his concerns regarding the BCVWD participation in the Sites Reservoir Project, and stated that it's an investment for the future, but not a current solution for water supply for the region. He stated that the water is north of the Delta, therefore, the reliability factor is an issue.

*Mr.* Jeff Davis, General Manager of the San Gorgonio Pass Water Agency (SGPWA), gave a power-point presentation on the Sites Reservoir Project. He shared that the potential water reservoir has been studied for years and that one of the advantages of the Sites Reservoir Project is that it comes with a built-

in environmental component. He said the project is located in the north Sacramento Valley, half way between the Delta and Lake Shasta. He pointed out that the location is in northern California, which tends to get more rain than southern California.

*Mr.* Davis demonstrated through graphs the amount of possible water storage and stated that the facilities would have a storage capacity of 1.3 to 1.8 million acre feet, utilizing existing infrastructure to pump water south. He also demonstrated the dry year yields, which is when you would get the most benefit. He shared that this project would be owned by a Joint Powers Authority, but the operations would be run by the Department of Water Resources.

*Mr.* Davis shared possible water supply benefits, which included: improving the Delta's ecology; another source of water independent of the Central Valley Project and the State Water Project contracts; that it integrates Shasta releases for the cold water pool, which increases the supply of the San Luis unit in the Central Valley Project; it's interruptible water (Article 21) which could extend the duration; and it provides for refuge water for wildlife.

*Mr.* Davis went over Proposition 1 funding, which states that the maximum state cost-share for funded public benefits would be fifty percent, and fifty percent of that would be for the ecosystem. He went over the estimated public benefits in dollars. He shared the range of construction costs, which can range from three to four billion dollars. He explained that Prop 1, Chapter 8 has \$2.7 billion available, but the dollar amount earmarked for the Sites Reservoir Project is unknown. He explained bond obligations would need to be created to pay for infrastructure, that initial funding would have to be provided by participating members, and explained that most likely Prop 1, Chapter 8 dollars would not be available until after phase 1, which is the application phase. He concluded his presentation by sharing that the SGPWA is participating in this project and stated that if BCVWD wanted to participate in the Sites Reservoir Project, a decision would have to be made before the submittal of proposal to participate deadline, which is July 29<sup>th</sup>, 2016.

General Manager Fraser asked for more clarity from Mr. Davis to help the Board understand the actual costs and risks in the investment.

After discussion, there was a consensus by all board members to hold a Special Meeting on July 27, 2016 at 7:00 p.m., for a decision.

- **SUBJECT:** Consider Authorization of the General Manager to Execute a Contract for Professional Diving Services to Conduct Inspections and Cleaning of Potable Water Reservoirs

### **Recommendation**

The Board authorizes the General Manager to enter into a contract for professional diving services with H2O Solutions, LLC to conduct annual cleaning and inspection of potable water reservoirs, in an amount not to exceed \$20,000.

### **Background**

In order to maintain water quality in the water distribution system and extend the life of a storage facility, storage tanks must be inspected and cleaned on a regular basis. Regular inspections of storage tanks helps to identify small problems that may be corrected before they become more severe and create water quality issues, lead to more expensive repairs, and cause premature tank coating failures.

The District operates a total of fourteen water storage tanks which are cleaned and inspected by professional divers every two to four years on a rotating schedule of three to four tanks per year. Tanks are scheduled for cleaning based on conditions that are identified during routine tank inspections conducted by District staff that may affect the performance and/or the life of the tank.

Staff has issued a Request for Quotations (RFQ) for the cleaning and inspection of four tanks to be conducted this year. The RFQ was sent out to four commercial diving companies and posted on the District's website. Only one out of four companies that made inquiries related to the RFQ submitted a proposal by the due date.

The proposal that was received in a timely manner was submitted by H2O Solutions, LLC for a total project cost of \$17,895.60. Two of the other three companies contacted by staff regarding the project chose not to submit proposals as they were unable to meet the minimum qualifications listed in Attachment "D" of the attached RFQ as it relates to a NACE (National Association of Corrosion Engineers) Certified Inspector to be provided by the contactor to supervise the work.



### Fiscal Impact

There will be a fiscal impact to the District in the amount of \$20,000 for the completion of this project. This amount includes a contingency of \$2,104.40 to cover the cost of any additional work that may be required. Funds are available in the District's 2016 Operating Budget under Reservoirs Maintenance (GL 01-40-440-540078).

UNLESS OTHERWISE EXPRESSLY AGREED IN WRITING, ALL PURCHASES ARE SUBJECT TO THE FOLLOWING TERMS AND CONDITIONS:

1. Offer and Acceptance: The Purchase Order is an offer by the Beaumont-Cherry Valley Water District ("District") to enter into a contract; and any of the following acts constitute Supplier's acceptance of the Purchase Order and all terms and conditions stated therein: (a) Supplier's execution and delivery to District supplier own acknowledgment form; (b) Supplier's delivery of any goods ordered; or (c) Supplier's acceptance of any payment from District.

2. Prices: All prices shall be as stated in the Purchase Order and are firm and not subject to escalation. Supplier represents and warrants that the prices set forth in the Purchase Order are at least as low as those currently being quoted by Supplier to commercial or government users for the same goods, in like quantities, under similar circumstances.

3. Taxes: This purchase is subject to all applicable California sales and use taxes. District is exempt from federal excise tax and will provide an exemption certificate, upon request.

4. Terms of Payment: Payment terms shall be net thirty (30) days from the date of receipt of invoice or acceptance of goods, whichever occurs last. If District is entitled to a cash discount, the period of computation shall commence on the date of receipt of invoice or acceptance of goods by District, whichever occurs last. District shall endeavor to pay each invoice within thirty (30) days, but shall not be responsible to Supplier for additional charges, interest or penalties due to failure to pay within that period.

5. Quantities: Supplier shall deliver the exact quantities specified in the Purchase Order. District reserves the right to reject incomplete deliveries and to return at Supplier's risk and expense excess quantities delivered.

6. Packaging and Shipment: Goods shall be packaged, marked and otherwise prepared for shipment by Supplier in suitable containers in accordance with sound commercial practices. Supplier shall include an itemized packing list with each shipment which includes the District's Purchase Order number.

7. Delivery: Time is of the essence in the performance of the Purchase Order. If delivery of goods cannot be made at the specified time, Supplier shall promptly notify District of the earliest possible date for delivery. Notwithstanding such notice, if Supplier, for any reason whatsoever, fails to deliver goods within the time specified, District may terminate the Purchase Order or any part thereof without liability except for goods previously delivered and accepted. District's receipt or acceptance of all or part of a nonconforming delivery shall not constitute a waiver of any claim, right or remedy District has under the Purchase Order or applicable law.

**8. Title and Risk of Loss:** The Purchase Order shall specify an FOB ("free on board") point, which shall be either the shipping point or the destination of the goods. If the Purchase Order specifies FOB destination, all shipping charges shall be prepaid by Supplier in full and included in the unit price. Supplier retains title to the goods and risk of loss until the goods have reached the designated destination. If the Purchase Order specifies FOB shipping point, Supplier shall prepay all shipping charges, route the goods on the least expensive common carrier in compliance with the required delivery date, and add shipping charges to the invoice as a separate line item. Buyer assumes title to the goods and risk of loss at the shipping point. No shipping charges will be allowed unless specified.

**9. Inspection and Rejection:** Goods shall be received subject to District inspection, testing, approval and acceptance at District premises notwithstanding any prior payment for such goods. Goods rejected by District as not conforming to the Purchase Order may be returned to Supplier at Supplier's risk and expense and shall not be replaced by Supplier without written authorization from District. Substitutions are not permitted except upon specific written authorization of District.

**10. Warranties:** In addition to any other express or implied warranties, Supplier warrants that all goods delivered under the Purchase Order will be new; suitable for the use intended; of the grade and quality specified; free from all defects in design, material and workmanship; in conformance with all samples, drawings, descriptions and specifications furnished by District; in compliance with all applicable federal, state, and local laws and regulations; and free of liens and encumbrances. These warranties shall not be deemed to exclude Supplier's standard warranties or other rights or warranties which District may have or obtain. At its expense and option, Supplier shall replace or repair any goods not conforming to the foregoing warranties. If, after notice, Supplier fails promptly to replace or repair any such goods, Supplier shall promptly refund to District the full purchase price paid by District for such goods.

**11.** Compliance with Laws: (a) Supplier shall comply with all applicable governmental laws, ordinances, codes, rules, regulations, programs, plans and orders in the performance of the Purchase Order.

(b) Supplier shall be in full compliance with any and all permit or licensing requirements in connection with the manufacture, sale, shipment and/or installation of the goods specified in the Purchase Order.

(c) If, in connection with the specified goods, Supplier is required to comply with the Occupational Safety and Health Act hazardous communications standard, Supplier agrees to provide copies of the applicable Material Safety Data Sheets at the time of delivery of the goods.

**12.** Safety and Health Requirements: Goods supplied shall comply with all federal and state Occupational Safety and Health Administration requirements and with all California safety and health requirements.

**13.** Assignment: Supplier shall not delegate or subcontract any duties or assign any rights or claims under the Purchase Order without District's prior written consent.

**14.** Waiver: Failure of District to enforce any provision of the Purchase Order shall not constitute a waiver or relinquishment by District of the right to such performance in the future nor of the right to enforce any other provision of the Purchase Order.

**15.** Severability: If any provision of the Purchase Order is declared by a court to be illegal or in conflict with any law, the validity of the remaining terms and conditions shall not be affected; and the rights and obligations of the parties shall be construed and enforced as if the Purchase Order did not contain the particular provision held to be invalid.

**16.** Patents, Copyrights or Trademarks: Supplier shall hold harmless and fully indemnify District and its officers, employees and agents from all damages or claims for damages, costs or expenses in law or equity that may arise for any infringement of the patent right, copyright or trademark of any person as a consequence of the use by District or any of its officers, employees or agents, of goods supplied under this Purchase Order.

**17.** Change Orders: District shall have the right to revoke, amend, or modify the Purchase Order at any time by issuance of a written Change Order. No verbal revocations, amendments or modifications shall be held binding on District; and District is not required to compensate Supplier for goods not authorized by written Change Order. Supplier's receipt of District's written Change Order without response received by District within ten (10) days or Supplier's shipment or other performance reflecting the change, whichever occurs first, shall constitute Supplier's acceptance of the change without any price or other adjustment.

**18. ### IN-SERVICE CLEANING AND INSPECTION OF POTABLE WATER STORAGE RESERVOIRS USING COMMERICAL DIVERS

### PART 1 -- GENERAL

### 1.01 PROJECT SCOPE

Requirements specified in Conditions of the Contract and Attachments A, B, C, and D form a part of this Section. The Work of this Section includes all labor, machinery, construction equipment and materials to provide the services necessary to perform in-service cleaning, inspection of potable water storage reservoirs using commercial divers, and performance of minor repairs. The Contractor shall furnish all labor, materials, equipment, insurance, training, and certifications necessary to complete the specified services.

The main purpose of this project is to perform sediment removal and a comprehensive evaluation of the interior and exterior condition of the reservoir(s). The objective of the project is to provide the Beaumont-Cherry Valley Water District (District) with detailed information and recommendations to maximize the serviceable life of each tank and provide information for possible modifications and/or repairs to improve operational effectiveness.

### All inspections and cleaning service are to be conducted with the tank full or partially full and in service. Water levels cannot be controlled for these services.

Specific work to be performed includes cleaning of accumulated bottom sediment, removal of any debris and the visual and video inspection of the four (4) domestic water storage reservoirs set forth in Appendix 1 located at the end of this Section utilizing certified commercial divers trained in cleaning and inspection of potable water reservoirs. It is the intent of the Beaumont-Cherry Valley Water District to utilize the reported inspection findings for documentation of routine preventative maintenance on the listed reservoirs. This specification requires specific documentation as detailed herein.

The Vendor shall perform a comprehensive interior inspection of the reservoir(s) in accordance with AWWA M42 Manual of Water Supply Practices "Steel Water-Storage Tanks" and/or AWWA Standard D110-86 "Wire-Wound Circular Prestessed-Concrete Water Tanks".

The cleaning and inspection services shall be performed while the reservoirs are in service without causing disruption to the District's well pumping and booster facilities and the District's transmission facilities. Specifically, the District will **not** have to make arrangements for:

- 1. Additional utility personnel or equipment (i.e. pressure relief valves, scaffolding, high pressure hoses, etc.)
- 2. Special scheduling no interruption of existing facilities operation

The Vendor shall provide high quality color digital video inspection of 100% of all internal surfaces, including the roof and roof support structure. The Video from the underwater camera shall be narrated by at least a NACE Level II Coating Inspector. The inspector shall be able to remove coatings and corrosion products on the internal submerged surfaces for direct examination of metal loss, pit depth, and coating failure.

### 1.04 GENERAL WATER DIVING SPECIFICATIONS

Specifications for Potable Water Diving Operations

- A. All diving operations to be conducted by certified commercial divers who are ACDE cardholders. Alternatively, divers who have completed specialized military training i.e., Navy 1st or 2nd Class Dive Courses or Master dive School shall also qualify.
- B. All diving operations shall be conducted with surface-supplied commercial grade diving equipment, including compressor (or compressed air bottle storage system), volume tank, air control system filter system and pneumofathometer. ### 1.05 UNDERWATER CLEANING SPECIFICATIONS

- A. Based upon the results of specific reservoir inspection, specific reservoirs will require sediment removal. The final decision to clean each reservoir will be made on a case by case basis by the Owners Representative.
- B. Cleaning will be conducted with the reservoir full or partially full and in operation. Bottom sediment shall be removed and disposed of on site.
- C. All cleaning equipment shall be disinfected on site in accordance with AWWA C652. For the purpose of this bid, the Vendor should assume that the sediment depth is as set forth in Appendix A located at the end of this section.
- D. Unit prices set forth in Attachment "C" shall be provided for additional sediment removal in excess of the level set forth in Attachment "C".

All accumulated bottom sediment and debris shall be removed in a manner that does not compromise the tank integrity and/or coating system. Work shall not cause disruption to the use or quality of the water. The cleaning procedures shall not create any visible turbidity in the water column. In addition to cleaning all sediment and other materials from the floor of the reservoir, the vendor shall ensure that all sediment and other materials is removed from all wall seams, support column bases, plumbing fixtures and supports, man entries, and any other areas where the vacuum does not reach during normal floor cleaning

Removed water must be de-chlorinated by the Vendor.

The total price entered on the Quotation Sheet (Attachment "C") shall be based on the removal of sediments up to the height entered into the quotation sheet, averaged over the entire floor area. Contractor's quote shall also provide a unit price, per cubic yard, for the removal of bottom sediment in excess of the sediment depth listed for each reservoir in Attachment "C".

#### 3.04 PAINT ANALYSIS

Interior and Exterior paint samples shall be tested per EPA 6010B for the presence of Lead, Cadmium, and Chromium.

#### 3.05 REPORT

The report shall be prepared by a NACE Certified Coating Inspector and stamped by a Registered Professional Engineer. The report shall contain at least the following minimum items for each reservoir inspected:

- A. A summary of the tank conditions and recommendations within thirty days of the inspection of each tank
- B. Evaluation of each tank interior and exterior coatings including recommendations
- C. 20 high resolution digital photographs (minimum) of interior and exterior surfaces with date stamp provided digitally in "jpeg" file format
- D. Detailed notes of the divers observations and comments corresponding to each photograph
- E. Detailed recommendations for any safety, sanitary or rehabilitations requirements along with estimated costs.
- F. Electronic copy of report and support information. Report text shall be submitted in Microsoft Word and/or Excel format as well as a PDF copy of same

#### **DRAFT CONTRACT FOR PUBLIC WORK**

#### 1. <u>Parties and Date</u>

This Contract is entered into this \_\_\_\_\_ day of \_\_\_\_\_\_, 2016, between the BEAUMONT-CHERRY VALLEY WATER DISTRICT, a California Irrigation (Special) District ("District"), and \_\_\_\_\_\_ ("Contractor"), for the Work described as follows: Furnishing Reservoir Cleaning, Inspection, and Minor Repair work.

#### 2. <u>Consideration</u>

In consideration of the mutual covenants hereinafter contained, District and Contractor agree to comply with the terms of this Contract and to faithfully perform their duties hereunder.

#### 3. Duties of Contractor

3.1 Contractor agrees to furnish all labor, tools, and equipment necessary to complete the work hereinafter described. Contractor hereby guarantees that all work to be performed by it hereunder will be performed in a good and workmanlike manner. The Work to be performed by Contractor is described on Exhibit "A" attached hereto and by this reference incorporated herein. Pursuant to Public Contract Code Section 3300, Contractor shall possess an active and current Contractor's License, Class A or C-57, which shall be maintained throughout the term of this Contract.

3.2 Contractor shall complete all work required herein on or before **December 1**,

#### 2016.

3.3 Contractor shall furnish District with labor and material releases from all subcontractors performing work on, or furnishing materials for, the job prior to final payment by District.

3.4 Contractor hereby guarantees that all materials and workmanship furnished by him under the Contract will meet fully all requirements thereof as to quality or workmanship and of materials furnished by him

3.5 Copies of the prevailing rate of per diem wages for each craft, classification or type of worker needed to execute this Contract are available to interested parties upon request. If the total amount of this Contract is \$1,000 or more, Contractor agrees to pay such prevailing rates to each workman needed to execute the work required under this Contract and further agrees to comply with the penalty provisions of Section 1775 of the Labor Code in the event of its failure to pay prevailing rates. Pursuant to Section 1727 of the Labor Code, all wages and penalties withheld for failure of Contractor

to pay such per diem wages shall be transferred by District to the State Labor Commissioner for disbursement, should Contractor fail to bring suit for recovery within ninety (90) days after completion of the Contract or acceptance of the work.

3.6 Contractor shall pay travel subsistence payments to each workman needed to execute the work, as such travel and subsistence payments are defined in the applicable collective bargaining agreements filed in accordance with Section 1773.8 of the Labor Code.

3.7 When Contractor employs workmen in an apprenticeable craft or trade, Contractor shall comply with the provisions of Section 1777.5 of the Labor Code with respect to the employment of properly registered apprentices upon public works. The primary responsibility for compliance with said section for all apprenticeable occupations shall be with Contractor.

3.8 Contractor is advised that eight (8) hours labor constitutes a legal day's work. Pursuant to Section 1813 of the Labor Code, Contractor shall forfeit a penalty of \$25.00 per worker for each day that each worker is permitted to work more than eight (8) hours in any one calendar day and forty (40) hours in any one calendar week, except when payment for overtime is made at not less than one and one-half (1-1/2) times the basic rate for that worker.

3.9 In accordance with the requirements of Labor Code Section 1776, Contractor shall keep accurate payroll records on forms provided by the Division of Labor Standards Enforcement, or keep payroll records containing the same information required by such forms, and shall make any such records available for inspection.

3.10 Contractor shall keep himself fully informed of all laws and regulations in any manner affecting the performance of the Contract work, and shall indemnify District and District's agents against any liability arising from violation of any such law or regulation.

3.11 Contractor shall at its own expense maintain at least the following insurance coverages throughout the performance of this Contract:

(a) Worker's compensation insurance coverages for all persons employed or to be employed in the performance of this Contract, which insurance shall at all times be maintained in strict accordance with the requirements of the current California Worker's Compensation Insurance Laws.

(b) General commercial liability insurance coverage of at least \$2,000,000 per occurrence and \$2,000,000 general aggregate insuring Contractor and naming District as an additional insured for all claims for bodily injury, personal injury and property damage, arising out of or in connection with any operations under this Contract.

(c) Automobile liability insurance coverage with a limit of liability of \$2,000,000 per accident Combined Single Limit.

(d) Course of construction insurance with a limit of liability equal to the full contract amount, unless waived in writing by District.

Prior to commencement of any work under this Contract, Contractor shall obtain and furnish to District a Certificate of Insurance as to each type of insurance required, which certificate shall be on the form provided to Contractor by District.

3.12 Contractor shall be responsible for all loss and damage which may arise out of the nature of the work agreed to herein, or from the action of the elements, or from any unforeseen difficulties which may arise or be encountered in the prosecution of the work until same is fully completed and accepted by District. However, Contractor shall be responsible for damage proximately caused by an act of God within the meaning of Section 4150 of the Government Code only to the extent of five percent (5%) of the contract amount.

3.13 Contractor shall indemnify and hold harmless District, its agents and employees, from and against all claims, damages, losses and expenses, including attorney's fees, arising out of or resulting from performance of work under this Contract and which are attributable to bodily injury, sickness, disease or death, or to injury to or destruction of tangible property, including the loss of use resulting therefrom, caused in whole or in part by any negligent or willful act or omission of the Contractor or anyone directly or indirectly employed by him or for whose acts he may be liable.

3.14 Contractor shall be responsible for securing and paying for all permits and licenses necessary to perform the work described herein.

3.15 If the work entails trenching of five (5) feet or more in depth, Contractor shall make adequate provisions for shoring, bracing, sloping, or other protection from the hazard of caving ground.

3.16 As required by Public Contract Code Section 7104, Contractor shall promptly, and prior to disturbance of conditions, notify District of (a) any material discovered in excavation that Contractor believes to be a hazardous waste that is required to be removed to a Class I, Class II, or Class III disposal site; (b) subsurface or latent physical conditions at the site differing from those indicated by District; and (c) unknown physical conditions of an unusual nature at the site, significantly different from those ordinarily encountered in such contract work. Upon notification, District will promptly investigate the conditions to determine whether a change order is appropriate. In the event of a dispute, Contractor shall not be excused from any scheduled completion date but will retain all rights provided by the Contract or by law for resolving the dispute.

#### 4. <u>District's Responsibilities</u>

4.1 As consideration for performance of the work required herein, District agrees to pay Contractor the total contract amount of \_\_\_\_\_\_, (\$\_\_\_\_\_), provided that such amount shall be subject to adjustment pursuant to written change orders signed in advance by District.

4.2 Contractor shall submit progress payment invoices to District at the end of each calendar month during the term of the Contract. All progress payment invoices shall be subject to approval by the District prior to payment by the District. Such progress payment invoices shall be made

in accordance with Section 20104.50 of the California Public Contract Code, requiring District to make a determination of suitability of the payment request within seven (7) days of receipt of such request and further requiring District to make payment on properly submitted progress payment invoices within thirty (30) days in order to avoid interest payments to the Contractor upon such amounts.

4.3 When the Contractor determines that he has completed the work required herein, Contractor shall so notify District in writing and shall furnish all labor and material releases required by Section 3.3 of this Contract. District shall thereupon inspect the work and, if acceptable, shall pay to Contractor the contract price, less any amount which District may be authorized or directed by law to retain. Payment of retention proceeds due to Contractor shall be made no later than sixty (60) calendar days after such final acceptance by District, in accordance with Section 7107 of the California Public Contract Code. Contractor is hereby alerted to provisions of Section 7107 of the California Public Contract Code, requiring Contractor to pay each of its subcontractors from whom retention has been withheld, each subcontractor's share of the retention received, within ten (10) calendar days from the time that all or any portion of such retention proceeds are received by Contractor from District. District will allow Contractor to substitute qualified securities, deposited with District or a qualified escrow agent, in lieu of contract retentions in accordance with provisions of California Public Contract Code, Section 22300. The escrow agreement used in such instance shall be substantially similar to that form set out in Section 22300 of the Public Contract Code. District will provide this form to the Contractor upon request.

4.4 To the extent required by Section 4215 of the Government Code, District shall compensate Contractor for the costs of locating and repairing damage to underground utility facilities not due to the failure of Contractor to exercise reasonable care, and removing or relocating underground utility facilities not indicated in the construction drawings and for equipment necessarily idled during such work. Contractor shall not be assessed liquidated damages for delay caused by failure of District to provide for removal or relocation of such utility facilities.

#### 5. <u>Contractual Relationship</u>

It is expressly agreed that Contractor is an independent contractor, and neither Contractor nor any of its employees shall be deemed employees of District. Contractor shall have full supervision over all workers on the job, including equipment, drivers, and operators, and neither District nor any of District's agents shall be held responsible for any action of Contractor under this Contract. Should any question arise regarding the meaning or import of any of the provisions of this Contract or written or oral instructions from District, the matter shall be referred to District's General Manager, whose decision shall be binding upon Contractor.

#### 6. <u>Assignment Forbidden</u>

Contractor shall not assign or transfer this Contract or any right, title or interest herein without the prior written consent of District. If contractor attempts an assignment of this Contract or any right or interest herein, District may, at its option, terminate and revoke the Contract and shall thereupon be relieved from any and all obligations to Contractor or his assignee or transferee.

#### 7. <u>Time of Essence</u>

Time is of the essence in the performance of this Contract. Contractor will be assessed liquidated damages in the amount of \$200.00 per calendar day for each day of unauthorized delay in completing performance.

#### 8. <u>Termination</u>

This Contract may be terminated by District at any time by giving Contractor seven (7) days advance written notice. In the event of termination by District for any reason other than the fault of the Contractor, District shall pay Contractor for all work performed up to that time as provided herein. In the event of breach of the Contract by Contractor, District may terminate the Contract immediately without notice, may reduce payment to the Contractor in the amount necessary to offset District's resulting damages, and may pursue any other available recourse against Contractor.

#### 9. <u>Dispute Resolution</u>

Any separate demand by Contractor for the payment of money or damages shall be resolved in accordance with Public Contract Code Sections 20104 <u>et seq</u>., if they apply. Copies of those sections are available upon request and by this reference are incorporated herein.

#### 10. Attorney's Fees and Costs

If any action is necessary to enforce or interpret the terms of this Contract, the prevailing party shall be entitled to recover from the losing party attorney's fees in an amount determined to be reasonable by the court, together with costs and necessary disbursements.

#### **Recommendation:**

Consideration of request for a "Will Serve Letter" for domestic water service for three (3) new parcels that will be created by subdividing an existing parcel (Riverside County Assessor's Parcel No. 402-200-005) with District water service into 4 separate parcels.

#### Background:

The Applicant, William K. Lattin, has requested water service from the District for three (3) proposed parcels which will be created by subdividing an existing parcel located at 10707 Jonathan Avenue (Riverside County APN No. 402-200-005). Said parcel currently receives water service from the District for the existing residence located on the parcel. The proposed subdivision creates three new parcels which are set forth on Parcel Map No. 37080. The County of Riverside requires that a "Will Serve Letter" be provided for the new parcels before the County will finalize Tentative Parcel Map No. 37080.

Said property is located north of Lincoln Street and west of Jonathan Avenue in the Community of Cherry Valley, California (Figure No. 1). This parcel is currently located within the District Boundary. The Applicant plans to construct three (3) new residences on the new parcels. Applicant will be required to secure the necessary approvals from the County of Riverside.

The Applicant has delayed submittal of this "Will Serve Letter" application due to the District's Resolution 2014-05 which has prohibited the issuance of new "Will Serve Letters" for projects not previously considered by the District that have more than two Equivalent Dwelling Units worth of demand. The Applicants development request is for three additional dwelling units and associated water services to be added to the existing parcel of land (once subdivided). The Applicant has requested that this item now be considered by the Board of Directors since the State of California is not requiring mandatory conservation within the District service area which causes the restriction of water services per the District's Resolution 2014-05.

It should be noted that some condition of drought still appears to exist in California, however, the State of California (State) mandatory conservation requirements for each California Water Supplier is now based upon the ability of that water supplier to meet three years of water supply in the event another drought is experienced similar to the previous three years. The District submitted water supply and storage information related to this supply requirement to the State, and the State has published that mandatory conservation will not be required within the District's service area. Specifically, the District has three years of water in storage to meet drought supply requirements as set forth by the State of California.

The District's Resolution 2014-05 required three conditions to be met under Item 1 of that resolution in order for "Will Serve Letter" issuance to be suspended. Condition 1. (b) of said Resolution requires: "There is in effect mandatory conservation measures applicable to the District's ratepayers imposed directly by the State of California, or imposed by implementation of District conservation measures in accordance with the District's Urban Water Management Plan". At this time, District Staff identifies that this condition no longer exists due to the fact that the State of California is no longer requiring mandatory conservation from the District.



The impact of these three additional residences on the District's water supply system is minimal. The Applicant will be expected to pay applicable Facilities Fees, extend existing facilities as necessary to provide for fire flow, and pay and non-tract water service installation fees for the three (3) new parcels. New water main facilities may be required to support fire flow requirements set forth by Riverside County prior to project development. The Applicant shall extend water mains across the project frontages as necessary to provide fire flow requirements and shall pay actual fees in effect at the time of application for service installation.

Final meter size for each new lot shall be determined by the Applicant and the Applicant may be subject by the County of Riverside to provide residential fire sprinklers for the property.

#### Conditions:

The Applicant shall conform to all District requirements for water service and all County of Riverside requirements.

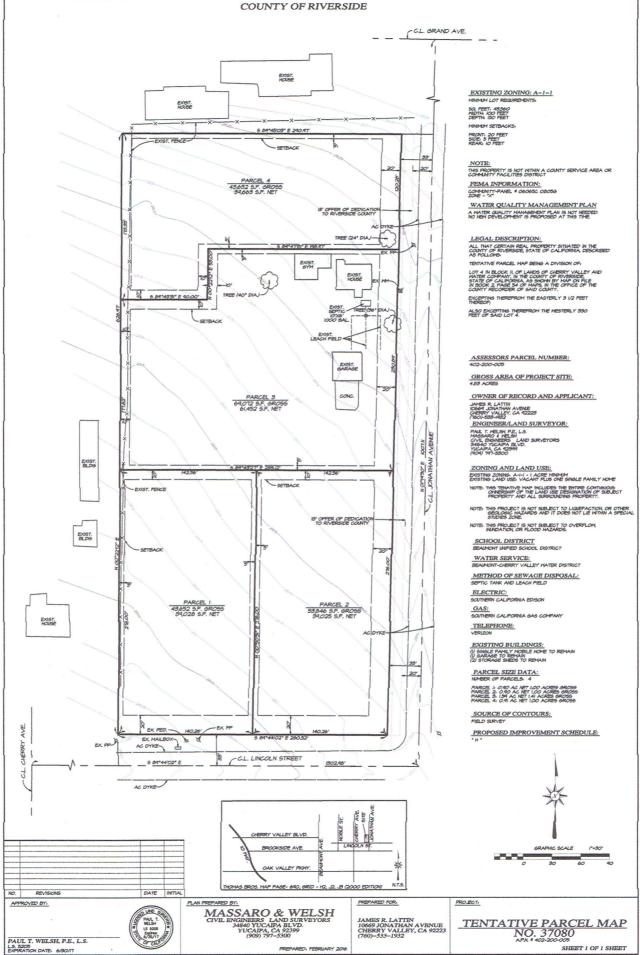
- 1. The Applicant will be required to pay front footage fees along all property frontages where facilities are currently installed.
- 2. The Applicant shall conform to all District requirements and all County of Riverside requirements.
- 3. To minimize the use of potable water, the District requires that the applicant conform to the County of Riverside Landscaping Ordinances which pertains to water efficient landscape requirements and the following:
  - a. Landscaped areas which have turf, shall have "smart irrigation controllers" which use Evapotranspiration (ET) data to automatically control the watering. Systems shall have an automatic rain sensor to prevent watering during and shortly after rainfall. Automatically determine watering schedule based on weather conditions, and not require seasonal monitoring changes. Orchard areas, if any, shall have drip irrigation.
  - b. Landscaping in non-turf areas should be drought tolerant consisting of planting materials similar to that at the District's demonstration garden at the Groundwater Recharge site. Irrigation systems for these areas should be drip or bubbler type.
- 4. The Applicant's project will impose additional water demands on the District's existing system. Service to the project will be contingent upon acquisition of imported water obtained from the San Gorgonio Pass Water Agency and non-potable (recycled) water obtained from the City of Beaumont, Yucaipa Valley Water District or other sources.

#### **Fiscal Impact:**

There will be no fiscal impact to the District as all the fees and deposits should be paid for by the Applicant.

Refer to the Applicant's (Pardee Homes) attached request for a second extension of "Will Serve Letters" For Tentative Tract 31469 and 31470 dated September 9, 2014.

Since the issuance of the attached "Will Serve Letters" the Applicant has continuously engaged in development and construction activities associated with Tentative Tract Maps 31469 and 31470. The Applicant's completed work over the last two years has included continuous processing of water improvement plans and construction of those facilities for both local area facilities and in-tract facilities associated with these Tentative Tract Maps with the District.

The requested "Will Serve Letter" extension includes domestic (potable) water service and nonpotable (recycled) water service as part of the Development of Tentative Tract Maps 31469 and 31470.

The Applicant will need to secure the final project approvals from the District and the City of Beaumont for the remaining areas located within Tentative Tract 31469 and Tentative Tract 31470.

Based upon the fact that the project has been under continuous development and construction activities during the last year, District Staff recommends that the Board of Directors provide the second "Will Serve Letter" extension.

The impact of this development on the District's water supply system is identified in the District's 2013 Urban Water Management Plan Update.

#### **Conditions of Continued Development:**

During the continued project development the following conditions must be met:

- The Applicant shall enter into a water facilities extension agreement and pay all fees associated with the domestic and non-potable water services for each specific development area (Final Sub-Tracts within Tentative Tract Maps 31467 and 31470). The Applicant shall also pay all fees related to new fire service facilities including any facilities improvements that may be necessary to meet the fire flow requirements.
- 2. The Applicant shall pay front footage fees along all property frontages where facilities are currently installed.
- 3. The Applicant shall connect to the non-potable water system for irrigation supply. To minimize the use of potable water, the District requires the applicant conform to the City of Beaumont Landscaping Ordinances and Zoning Requirements and/or County of Riverside Landscaping Ordinances (as applicable) which pertains to water efficient landscape requirements and the following:
  - a. Landscaped areas which have turf, shall have "smart irrigation controllers" which use Evapotranspiration (ET) data to automatically control the watering. Systems shall have an automatic rain sensor to prevent watering during and shortly after rainfall and automatically determine watering schedule based on weather conditions, and not require seasonal monitoring changes. Orchard areas, if any, shall have drip irrigation.



- b. Landscaping in non-turf areas should be drought tolerant consisting of planting materials. Irrigation systems for these areas should be drip or bubbler type.
- 4. The Applicant shall conform to all District requirements and all City of Beaumont requirements.
- 5. This project's Plan of Service as well as the District's Urban Water Management Plan identifies a water supply component for recycled water to be provided by the District that is procured from the City of Beaumont. The Applicant shall secure entitlement to said non-potable water supply from the City of Beaumont that shall be conveyed to the District as necessary to support the project development including non-potable water use requirements and to offset of potable water demand created by this project. Said non-potable water supply shall be provided to the District by the City at a delivered cost not to exceed the cost per acre-foot of imported water available from the State Water Project supply as available from the San Gorgonio Pass Water Agency current Table "A" Allotment (currently \$317 per acre foot of water). The water quality of said non-potable water shall meet all Title 22 and Basin Plan requirements.
- 6. The Applicant's project will impose additional water demands on the District's existing system. Service to the project will be contingent upon acquisition of imported water obtained from the San Gorgonio Pass Water Agency and non-potable (recycled) water obtained from the City of Beaumont, Yucaipa Valley Water District or other sources.

#### Fiscal Impact:

There will be no fiscal impact to the District as all the fees and deposits will be paid for by the Applicant.

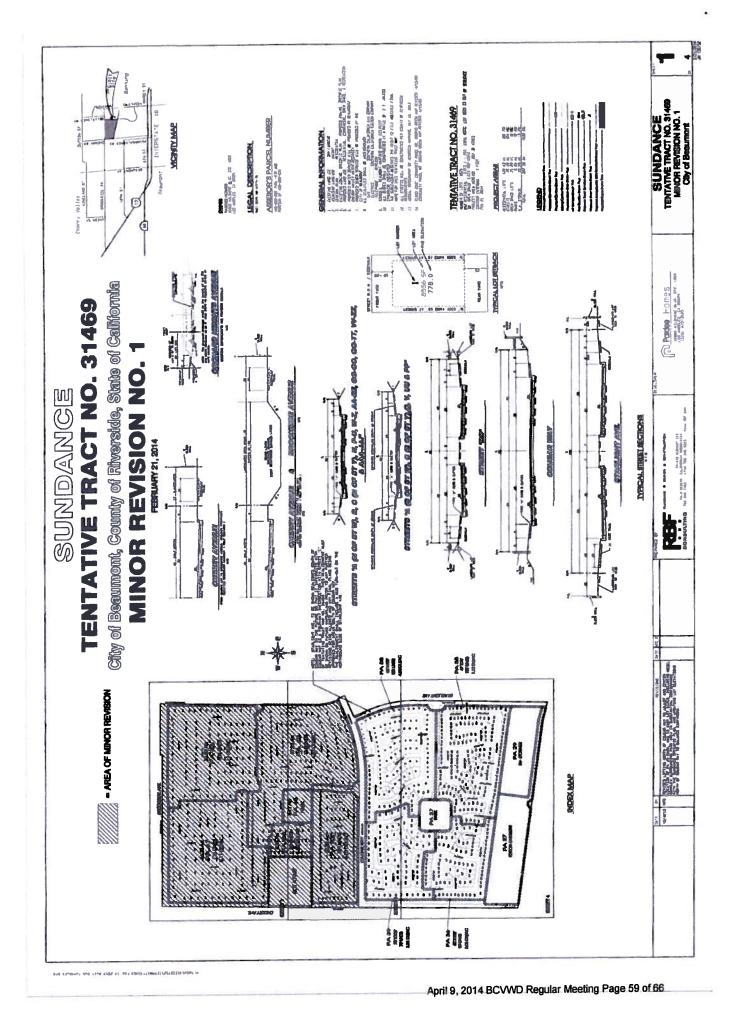

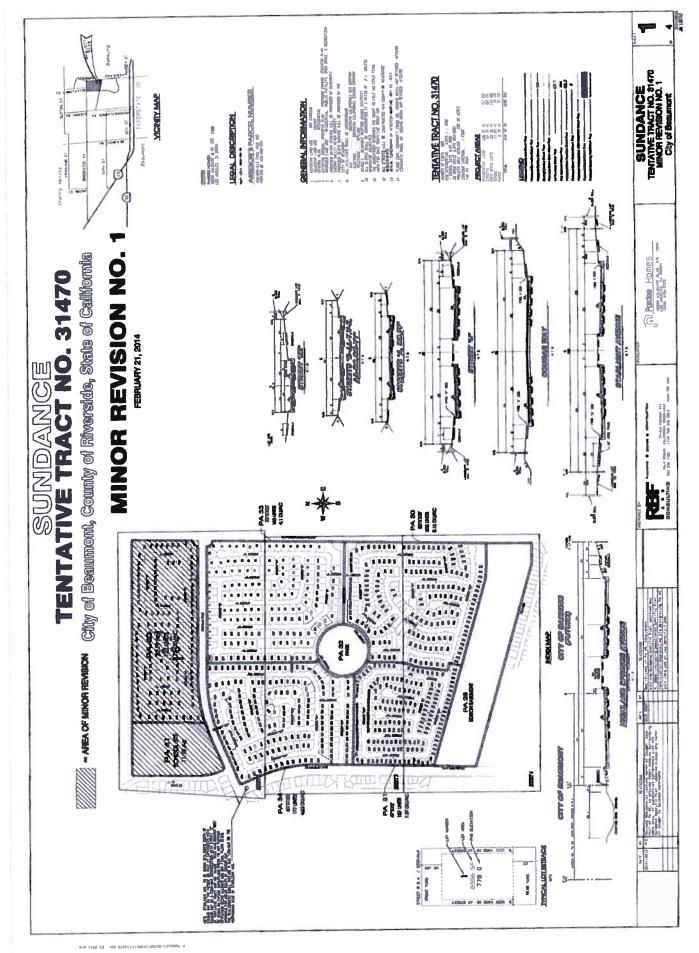

#### **Recommendation:**

Consideration of request for "Will Serve Letter" for Tentative Tract Map 36783 for ongoing development within SDC Fairway Canyon, LLC's Fairway Canyon Community (Oak Valley Partners Specific Plan).

#### Background:

Refer to the Applicant's (SDC Fairway Canyon LLC) attached request for a "Will Serve Letter" For Tentative Tract Map 36783 (Planning Area PA-21A) dated August 4, 2016. This project is part of the ongoing Fairway Canyon Development (see attached Fairway Canyon City of Beaumont Figure). This Development was part of a project identified within the Oak Valley Champions Specific Plan which included the SCPGA Golf Course (now Tukwet Canyon GC).

Tentative Tract 36783 consists of 53 single family homes proposed to occupy an area that was originally identified for a school site within the project Specific Plan. The Applicant has informed District Staff that the school site is not acceptable to the Beaumont Unified School District, and that the school site will either be relocated to another planning area within the Fairway Canyon Development or may be relocated to a new location in the Applicant's adjacent development (Summerwind Ranch Development) which resides within the City of Calimesa in Yucaipa Valley Water District's Service Area.

The Oak Valley Champions Specific Plan planned for 3,300 homes and to date 1,209 homes have been constructed. The Applicant has identified that the remapping of the area associated with TTM 36783 from the school site to residences will not increase the total number of approved homes for the project. District Staff did not to locate the original "Will Serve Letter" for this project during preparation of this Staff Report, however District files do include various executed agreements between the District and the Developer that include the total project area (3,300 homes) and includes the specific area identified as TTM 36783. Staff did locate the District prepared Annexation Plan of Service dated June 12, 2003 which included the area identified as TTM 36783. The areas included in the Plan of Service where annexed into the District's Service Area under LAFCO Annexation No. 2003-43 in 2004.



District Staff has reviewed the water demands related to the remapped residential area of TTM 36783 and identifies that the proposed 53 single family homes (53 EDUs) will not increase water demands significantly over the proposed elementary school. A review of water used at the Sundance Elementary School shows an annual demand of approximately 51 EDUs.

The Applicant last received updated "Will Serve Letters" for other Tracts associated with the Fairway Canyon Development from the District on December 17, 2013 for Tract 31462-7, 31462-8, and Tract 36558. These Tracts included a total of 372 dwelling units. The Applicant subsequently completed project engineering and District plan checking, executed Water Facilities and Mainline Extension Agreements with the District, and has commenced construction activities related to these Tracts. These three Tracts are currently under various states of construction as follows:

The Applicant will need to secure the final project approvals from the District and the City of Beaumont for the improvements located within Tentative Tract Map 36783.

Based upon the fact that the project has been under continuous development and construction activities since the last three "Will Serve Letter" extensions were granted, District Staff recommends that the Board of Directors provide a "Will Serve Letter" for this area since the difference in demands from the remapped Planning Area PA-21A does not significantly increase the demands that would have been associated with the School Site original water demands.

The impact of this development on the District's water supply system is identified in the District's 2013 Urban Water Management Plan Update.

#### **Conditions of Continued Development:**

During the continued project development the following conditions must be met:

- 1. The Applicant shall enter into a water facilities extension agreement and pay all fees associated with the domestic and non-potable water services. The Applicant shall also pay all fees related to new fire service facilities including any facilities improvements that may be necessary to meet the fire flow requirements.
- 2. The Applicant shall connect to the non-potable water system for irrigation supply. To minimize the use of potable water, the District requires the applicant conform to the City of Beaumont Landscaping Ordinances and Zoning Requirements and/or County of Riverside Landscaping Ordinances (as applicable) which pertains to water efficient landscape requirements and the following:
  - a. Landscaped areas which have turf, shall have "smart irrigation controllers" which use Evapotranspiration (ET) data to automatically control the watering. Systems shall have an automatic rain sensor to prevent watering during and shortly after



rainfall and automatically determine watering schedule based on weather conditions, and not require seasonal monitoring changes. Orchard areas, if any, shall have drip irrigation.

- b. Landscaping in non-turf areas should be drought tolerant consisting of planting materials. Irrigation systems for these areas should be drip or bubbler type.
- 3. The Applicant shall conform to all District requirements and all City of Beaumont requirements.
- 4. This project's Plan of Service as well as the District's Urban Water Management Plan identifies a water supply component for recycled water to be provided by the District that is procured from the City of Beaumont. The Applicant shall secure entitlement to said non-potable water supply from the City of Beaumont that shall be conveyed to the District as necessary to support the project development including non-potable water use requirements and to offset of potable water demand created by this project. Said non-potable water supply shall be provided to the District by the City at a delivered cost not to exceed the cost per acre-foot of imported water available from the State Water Project supply as available from the San Gorgonio Pass Water Agency current Table "A" Allotment (currently \$317 per acre foot of water). The water quality of said non-potable water shall meet all Title 22 and Basin Plan requirements.
- 5. The Applicant's project will impose additional water demands on the District's existing system. Service to the project will be contingent upon acquisition of imported water obtained from the San Gorgonio Pass Water Agency and non-potable (recycled) water obtained from the City of Beaumont, Yucaipa Valley Water District or other sources.

#### **Fiscal Impact:**

There will be no fiscal impact to the District as all the fees and deposits will be paid for by the Applicant.

Dear Dan:

We would like to request a Will Serve Letters for PA 21A in Fairway Canyon. This Planning area was originally determined to be a school site and the water calculations were based on that use. The Beaumont Unified School District has determined the site location is not suitable for an elementary school and will be looking at a site in the future depending on their needs.

We have re-mapped the site to single family homes at 4 DU/AC, which was allowed in the Specific Plan for alternative use in the event the School District chooses not to use the site. There will be 53 SFD homes 55' X 100'shown on TTM 36783. The additional units on this site will not increase the overall allowed units for Fairway Canyon as these units have been transferred from Planning Area 14 located on the corner of Champions and Tukwet. Planning Area 14 was approved for 178 courtyard type homes and has now been approved for 94 single family homes. Planning Area 21A is on Palmer Avenue and all infrastructure to and around the site has been installed.

This Planning Area is included in the next phase of development for Fairway Canyon. Currently there are 3,300 homes approved for Fairway Canyon and 1,209 are already completed and occupied. There are another 248 lots graded and 88 have been sold to Woodside; they are currently under construction with their first 3 phases of development. Another 130 are on the market to builders and we hope construction will start soon. Planning Area 14 with 94 homes will start grading in August and we hope to start grading Planning Area 21A by the end of the year.

The next area of development will be Planning Area 22, which will consist of approximately 230 lots and will be located off of Tukwet. All infrastructure on Tukwet and Sorenstam will be completed to provide service to Planning Area 22 and complete the connection of Tukwet from the I-10 to Oak Valley Parkway.
