Chair Hoffman noted an increase in cost for damage and theft; staff explained that a number of meters in new developments had been stolen, and this is a pass-through item ultimately paid by the developer.

Chair Hoffman suggested increasing the 2019 budget for Operations Materials and Supplies.

General Manager Jaggers explained the procedures and costs related to the mandatory water loss audit for state regulators.

In response to a question from Chair Hoffman, Mr. Jaggers described the CLA-valve maintenance expenses.

After review and discussion, the Committee recommended presenting the Financial Reports to the Board for approval.

5. Ongoing discussion regarding San Gorgonio Pass Water Agency water rate study and potential impacts on BCVWD

General Manager Jaggers noted this is an ongoing item to keep the F&A Committee apprised. Water managers are meeting to discuss water rates and capacity fees and the relationship of both. Jaggers noted the group is moving in an agreeable direction and the SGPWA seems receptive to considering some options. It had been hoped to have a determination in January, but it appears that is farther out, Jaggers said.
