SUBJECT: City of Beaumont Street Improvement Project and Discussion of Impact on

BCVWD Capital Improvement Plan Projects

Staff Recommendation

No recommendation. Information only.

Background

On September 2, 2020, District staff received a Utility Notice (first notice of project coordination) from the City of Beaumont (City) notifying the District of their planned Citywide Street Maintenance Project (Project). The City plans to resurface various streets/street segments in four separate areas of Beaumont (a project map is provided as **Attachment 1**). The proposed pavement repair/maintenance by the City will consist of either a Type II Slurry Seal, Cape Seal, or a complete asphalt pavement replacement of 3" thickness.

District Staff understands that the City proposes the following schedule:

City staff has requested that the District review the project information and complete and return the provided Project information Questionnaire (**Attachment 2**) by September 16, 2020 (2 weeks subsequent to notice date). At this time, the City of Beaumont has provided no real time to coordinate utility replacements or relocations due to their proposed construction schedules and the only coordination that could take place is to request that the City defer paving areas of conflict until District projects could be completed. At this time, District Staff identifies that 3 locations of paving will impact planned District projects in the immediate future (2021) due the new City paving moratorium.

Specifically, the City Ordinance passed on November 5, 2019 which placed a moratorium on pavement cuts on recently resurfaced streets (5 years for streets which have been fully constructed or re-constructed, 3 years for slurry sealed streets), there will be an impact to the District's Capital Improvement Projects (CIP) within a portion of the City's Project. District Staff has identified that there are five (5) possible conflicts between the District's CIP Pipeline Replacement Projects (identified over the next 4-5 years) as indicated on the Master Plan and the City's project.



A summary of the District's proposed Pipeline Replacement Projects and their anticipated project year is described below in Table 1:







SUBJECT: Update regarding District Declared Emergency for Well 21 and Well 24

Staff Recommendation

No recommendation. Information only.

Background

At the March 26, 2020 Beaumont-Cherry Valley Water District (BCVWD) Board of Directors Engineering Workshop, the Board ratified the General Manager's Declaration of a District Emergency to address the necessary immediate repairs to Well 21. It had been discussed at a previous Board meeting that Staff had detected vibration issues with Well 21 equipment. Staff indicated that due to the upcoming summer demand and possible materials and labor shortages due to COVID-19, an emergency should be declared and ratified by the Board.

At the June 25, 2020 BCVWD Board of Director's Engineering Workshop, the Board ratified the General Manager's Declaration of a District Emergency to address the necessary immediate repairs to Well 24. On June 19, 2020, the District's Production Staff noticed significant noise and vibration in the line shaft below the motor for Well 24. Well 24 is a high producing well for the BCVWD Distribution system, so this well being out of service constitutes an emergency.

This staff report serves as an update to the work that has been done and the financial impact to the District.

Summary

Three informal bids were solicited for each well and, being the lowest bids and most quickly able to respond, Legend Pump and Well Services, Inc. was selected to perform the work at both well sites.

Well 21

On March 6th, 2020, District Staff found significant vibration coming from subsurface equipment combined with a reduction in production at Well 21. An emergency condition was declared by the General Manager and ratified by the Board of Directors for immediate repairs of the Well 21 pumping unit. During the removal of the Well 21 pumping unit, it was found that nearly all of the column, tube and shaft had reached the end of its service life, exhibiting significant corrosion and pitting. Many of the joints had to be cut out during removal of the equipment. As a result, all of the column, tube, and shaft were replaced with new equipment. The vibration identified by District staff was verified as being caused by the failure of multiple impellers in the pumping unit bowl assembly. District staff identified an appropriate replacement pumping unit and said pumping unit was subsequently installed with the new column, tube, and shaft. The total cost to mobilize, remove old equipment, replace appurtenances, and reinstall equipment was \$133,034.57. Well 21 was returned to full service on July 22, 2020 with no further issue.



Well 24

On June 19th, 2020, District Staff identified significant vibration coming from subsurface equipment at Well 24. An emergency condition was declared by the General Manager and ratified by the Board of Directors for immediate repair. Upon removal and inspection, it was found that a bearing had failed relatively close to the surface resulting in only the removal of the top 100' of column, tube, and shaft. During removal, it was also identified that overspray of epoxy coating on the column threads had caused the column to become "glued" together. The removal of the top 100' of column resulted in cutting the column to access the tube and shaft. District staff identified that used column, of the appropriate size, existed in storage at District facilities. Said column was transported to Legend Pump and Well Services Inc. for cleaning and conditioning. Damaged bearings the failing pumping unit were replaced and the pumping equipment was reinstalled in order to quickly restore production from Well 24. Well 24 was returned to full service on June 28th, 2020.

Additionally, the repaired 600hp electric motor was identified to have significant damage to the rotor bars resulting in excess heat generation and will suffer an inevitable catastrophic failure of the electric motor. To prepare for this, District staff and the District's motor vendor identified that 600hp motors of the needed type are generally built to order by manufacturers with a 12 week delivery expectation. One 600hp motor was found to be in the country and available for immediate delivery, and the decision was made to purchase said motor as part of the emergency declaration. Sulzer, the District's electric motor vendor received the new motor and made necessary measurements and modifications for a seamless installation. The new 600hp electric motor is available for installation at a time of less demand or at the District's convenience. The total cost for mobilization, removal of 100' of column, tube, and shaft, replacement of damaged bearings, reinstallation of equipment and the purchase of a new 600hp electric motor was \$90,167.13.

Subsequent to returning Well 24 to full service, recent inspection of the Well 24 equipment by District staff has identified the likelihood of additional bearing issues at the "throttle bearing" further down and near the pumping unit. At this time, Well 24 is being reserved for high demand scenarios in anticipation of a full repair and rehabilitation activity near the end of this year. During said repair and rehabilitation efforts, the new electric motor will be installed.

Fiscal Impact

The emergency repair work done to Well 21 currently amounts to \$133,034.57 and the emergency repair work done to Well 24 amounts to \$90,167.13 for a total of \$223,201.70 which has been paid from Capital Improvement reserves.

SUBJECT: Bogart Park Transition Update and Scheduling of Dedication Plaque Activity

Staff Recommendation

No recommendation.

Background

President Covington requested an update of the status of Bogart Park activities and transition status at the September 10, 2020 Board Meeting as well as a summary of proposed dates for scheduling a Plaque dedication to be located at Bogart Park's entrance. This Staff Report serves to provide a brief history of recent events as well as provide an update to recent Beaumont-Cherry Valley Recreation and Park District (BCVRPD) activities.

On November 14, 2018 Beaumont-Cherry Valley Water District (BCVWD) Board of Directors Regular Board meeting), the BCVWD Board voted to authorize the assignment of the remaining term of a 99 year lease of District owned land included in Bogart Park to the BCVRPD from Riverside County. The Assignment and Assumption Agreement became effective on December 11, 2018 when it was signed by Riverside County Supervisor Chuck Washington. The term of this lease will end on October 4, 2030. Per Discussions with BCVRPD, BCVRPD hopes to begin discussions for lease extension of BCVWD owned properties in 2021.

Since December 2018, BCVRPD has been preforming operations and maintenance activities in Bogart Park. A listing of all activities performed by BCVRPD since December 2018 will be provided at the Engineering Workshop.

On June 9, 2020, the Riverside County Supervisors approved the transition of ownership of 80 acres of Riverside County owned land included in Bogart Park to BCVRPD and it was reported at the July 8, 2020 BCVRPD Board meeting that the Deed was recorded in the name of BCVRPD on July 1, 2020.

BCVRPD staff has proposed four (4) dates for the Plaque dedication: October 1, October 8, October 22, and October 29, 2020 with times beginning at 4 p.m.

Finally, Bogart Park has been affected by the Apple Fire and associated burn scar and a verbal update will be provided at the Engineering Workshop as to recent events and activities related to that event.

Fiscal Impact

There is no fiscal impact to the District.
